### Finance Report

• After eight (8) months of activity (02/28), Lab has a positive Cash Balance (\$1.3M) and a Net Income (Deficit) of -\$952K.

- The school has begun to receive its Federal Grant revenues (\$294,737 payment on February 22<sup>nd</sup>, to be followed in March-June by Titled funding and other ESSER II/ARP funding).
- The school meets the standard (Green) on 2/5 financial indicators tracked by the SD of Philadelphia with slight improvement in the last 30 days.
- Lab will receive \$5.1M in Federal COVID-19 Relief (ARP ESSER) funding (to be used by Sep 2024), a significant portion of which (\$1.54M) will <u>supplant current year (2021-22) personnel costs</u>.
- Lab's 2022-23 Budget process is underway and will likely necessitate a right-sizing of the school's staffing model.

# CEO's Report

**COVID-19 Pandemic Update:** As the world moves forward in the new normal created by the COVID pandemic, the guidelines have been drastically modified. This will impact how LAB handles new COVID cases.

Based on the information from the CDC Schools information session on 3/8/22:

- The mitigation survey must still be completed by the school administrator for each new case.
- There are additional "At Home" COVID tests that can be picked up for each student.
- It is recommended that the first batch be sent home with students for Spring Break so they can bring in the test when they return to school.
- Additional test can be sent home as needed.
- There are no further class closures for COVID cases.
- There is no further need for Social Distancing in schools.
- Masks are still required on any form of public transportation (SEPTA, School Buses, Taxi Cabs, etc.) until further notice.

In the case of positive cases MASKING IS THE NEW QUARANTINE:

- The class and any close contacts will wear masks for 10 days. Since LAB already wears masks this will impact LAB. Lab Charter WILL NOT be lifting the mask mandate at this time so everyone at LAB will be masked at all times.
- If individuals exposed are fully vaccinated then the masks can be worn for 5 days.
- LAB would need to have information on student vaccination rates for this to happen.

- Exposed individuals with no symptoms should test on day 5 to see if they are positive using the "At Home" tests LAB will send home.
- Any individual with symptoms after exposure should immediately test.
- LAB can provide the free At-Home tests from CDC Schools for any additional COVID cases.

**Food Service:** The Food Service AUN number was corrected by PDE. Payments are now being received by LAB. Additionally, a request has been made to the City for Spring 2022 Food Service Health Inspections.
